Task Force Presentation. Crystal Wynn-Lewis

- Racial and Ethnic Disparities: North Carolina Juvenile Justice System FY20 JJ Data Review
 - Presented statistics of the current data for North Carolina's Juvenile Justice System for FY 2019- 2020. <u>Please refer to power point to see in-depth data and</u> <u>recommendations</u>.
- Dr. Glenn Expressed concern with complaints and RRI specifically in Martin County. Dr. Glenn recommended that the Task Force brainstorm idea that would benefit the youth population that might not have access to a lot of resources.
- Crystal Wynn-Lewis explained how Juvenile Justice share the information with the counties to see where they need resources.
- Kelly Andrews expressed, that it was a matter of law enforcement utilizing youth programs. She explained that there should not be a reason why numbers are so high if the person in power used the programs to prevent high numbers of complaints. She stated that most counties have the resources to fight the high numbers that were shown. She suggested that more of an effort come from city council, police chiefs, or other stake holders to utilize youth programs instead of sending youth straight to detention centers. In general, the state needs to hire chiefs and high-power individual's that understand these issues.
- Deena Hayes-Greene Suggested that law enforcement receive cross system training.

RED Subcommittee Nominations. Dr. Taylor, Dr. McCarter, Members

- Nominations are open for RED-DMC Subcommittee.
- Vicki Foster has two recommendations.
- Chair, Dr. Taylor explained that the subcommittee will consist of 15 members that acquire knowledge and/or experience related to the overrepresentation of minority youth in the juvenile justice system, individual can be:
 - o Juvenile court judge
 - o Juvenile defender
 - Prosecutor with juvenile court experience
 - Social services/child welfare.
 - o Juvenile Justice court counselor
 - Court appointed special advocate
 - Family of induvial in juvenile justice system
 - Former juvenile justice individual
 - o Pediatrician/ adolescence health provider
 - Mental health professional
 - Law enforcement/FRO
 - School education/administration
 - o DMC/RED researcher
 - Race matter expertise
 - o JJPC/Juvenile service provider
- Chair, Dr. Taylor is excited about introducing new members to this subcommittee. There was an emphasis on youth representation.

RED Brief – JJ Awareness Month. Dr. McCarter

- Raising awareness of disparities and disproportionality in racial and ethnic outcomes within the juvenile justice system.
 - Annually collaborates with the counselors for children's rights to publish a series of publication in October early November in recognition of juvenile justice awareness month.

Agency Updates. Members

- Johnny Wilson: Received city funding to help citizens with rent, mortgage, and utility bills. Find a Friend program is still active, now they pick the kids up from home. The program is following appropriate procedures/screening for COVID.
- Race Matters for Juvenile Justice: They were involved in racial equity workshops. Also involved in a lot of presentations on a national level to share information and analysis.
- Guilford County: They are being mindful and keeping race on the table while interacting with child welfare, health care, and education. Also, they are acknowledging groups across the state that are leading with racial equity.
- Kelly Andrews: Mentioned pre-arrest diversion. The district attorney's office participates in post-arrest diversion during COVID. Felony allegations are being sent to diversions. They are also doing restorative justice circles, CBI groups, therapy, and counseling. Upon completion juveniles are eligible to a plea down for expunction or dismissal of charge.

- Vicki Foster: Is having discussions with new chief and deputy chief.
- Dr. Glenn established a racial equity and social justice center that provides COVID and community base program analysis. His team wants to understand if, and how -community-based programs are able to maintain their programs/effects despite the impact of COVID.

- The juvenile justice annual conference (virtual) is November 18- 20, 2020.
- Chair, Dr. Taylor wants the subcommittee to spend time talking about other data that the task force needs to gather in January meeting
