## G.S. 14-258.7. Annual reports of violations.

(a) The Department of Adult Correction shall report the following to the chairs of the Joint Legislative Oversight Committee on Justice and Public Safety by March 15 of each year.

(1) The number of incidents of any violation of this Article, G.S. 14-34.5(b), 14-34.7(b), or 14-34.7(c)(2) involving an employee or contractor of a detention facility operated by the State.

(2) The nature of the resolution of every incident of any violation of this Article, G.S. 14-34.5(b), 14-34.7(b), or 14-34.7(c)(2) involving an employee or contractor of a detention facility operated by the State.

## **Resolution of Incidents**

During calendar year 2023, there were no violations of G.S. 14-34.5(b) and 1 violation of G.S. 14-34.7(b) involving an employee or contractor working in a detention facility operated by the state. There were 107 violations of G.S. 14-34.7(c)(2). Out of the 107 violations, 0 offenders were convicted while 23 charges are still pending. The Department of Adult Correction continues to monitor these incidents and to take appropriate action to ensure the utmost safety of our employees, individuals in our custody, and all who enter our facilities.
